- 1. A LOWER TEMPERATURE ROD IS THE PREFERRED METHOD FOR CUTTING THE FILM.
- 2. IF THE HOT WIRE METHOD IS IN USE, THE WRAPPER SHOULD KEEP THE WIRE CLEAN AND MAINTAIN THE PROPER TENSION ON THE ROLL SO THAT THE WRAPPING FILM WILL PULL BACK TOWARDS THE ROLL AFTER IT IS CUT.
- 3. PROPER AIR CIRCULATION AND VENTILATION SHOULD BE MAINTAINED IN THE WRAPPING AREA.
- 4. WORKERS SHOULD NOT SMOKE IN MEATWRAPPING AREA.
- 5. PERSONNEL WITH A PRE-EMPLOYMENT OR LONG-STANDING HISTORY OF RESPIRATORY AILMENTS SHOULD NOT BE ASSIGNED TO THE MEAT WRAPPING ENVIRONMENT.
